Treasurer Report for OAIG – Dec. 13, 2023

Dear Intergroup Representatives and Board Members,



As of today, Wednesday, December 13, 2023, all cash and cheques have been deposited into the Intergroup bank account. Thank you to all groups and individuals who contributed over the past month. Your continued support of Intergroup allows us to continue carrying the message to still-suffering alcoholics inside and outside of our rooms.

UPDATES:

EOC Funds & End of Year Book Balancing:

All funds from the Eastern Ontario Conference have been deposited. In January, post-holidays, I'll collaborate with our bookkeeper to ensure our balance sheets are accurate using the EOC Treasurer's notes. This reconciliation will allow for the maintenance of precise financial records and the closing of the books for 2023.

Credit Card Update:

Thanks to John's efforts in updating our corporate financial registration with the Province of Ontario, our application for a BMO credit card is complete. We're awaiting its arrival, expected by the end of December or early January. With a \$2,000 limit secured against our bank account, this credit card will prevent board members from shouldering large expenses. Scheduled to pay off its balance automatically each month, it will be used for essential web tool subscriptions and necessary expenses, avoiding any interest charges.

PayPal Account Issue:

The ongoing issue with our frozen PayPal account continues to be challenging. Numerous hours have been invested in resolving this, often facing procedural roadblocks. With our updated corporate documents, I've escalated the issue to PayPal's higher management and am awaiting their response.

Prudent Reserve, GICs, 2024 Budget & Extra Funds:

With the EOC funds nearly reconciled, we can now focus on setting a prudent reserve for 2024 and preparing a budget, which will likely be presented in our February meeting. Assuming our operations continue as currently, I'm forecasting a \$30,000 prudent reserve, in line with GSO's recommendation for a year's operating expenses. This leads us to consider using our excess funds, estimated between \$10,000 to \$15,000. I encourage Intergroup Representatives to discuss potential uses for these funds with their groups, like supporting PI/CPC initiatives or seeding a 2024 Alkathon/Holidayathon-style event should it come into the Intergroup fold. Your feedback will be invaluable in shaping our approach.
