#### **Treasurer Needed for 2025**

#### **Allocation of Excess Funds**

We currently have approximately \$10,000 in excess funds that exceed our \$30,000 prudent reserve. These are your funds aimed at serving the Ottawa-area AA community. We have had some discussions regarding this, and members have been in contact to offer suggestions.

Based on the suggestions made so far, here are two current recommendations for consideration today during New Business.

## Intergroup Office: \$2500

- On February 28, 2024, we received a \$2,367.10 GST refund, and we will be receiving another refund of \$368.93 for the period just filed. This total is \$2736.03
- Upkeep is necessary for the OAIG office.
  - Improved security, including window coverings and new door locks.
  - Disposal of old furniture
  - New furniture, paint, frames for important pieces of local and broad AA history if needed, etc.
- Other items, as deemed necessary, to make the office an inviting and useful place.
